

Instructions for Authors

General instructions:

- the journal EU Agrarian Law is published twice a year,
- published papers have to be written in English language,
- author is responsible for the scientific accuracy, originality, and the formal appropriateness of the paper,
- the Editorial Board will not consider any paper or component of a paper that has been published or is under consideration for publication in other scientific journal,
- the Board reserves the right to refuse publication.

Submission of papers:

- deadlines for submission are: **30th April** and **30th October** of the respective year
- author is obliged to submit a **Statement** to the Editorial Board which claims whether the article has been offered to another publisher of scientific journal. The Statement form can be found at the web site: <http://old.fesrr.uniag.sk/chair/node/37>,
- **papers** have to be submitted to the Editorial Board electronically to the e-mail address: apeu@uniag.sk ,
- papers have to be submitted in .doc or .docx format (MS Word),
- the journal does not have article processing charges (APCs) nor article submission charges.

Paper format:

- **title of the paper** must be written in font size 16, bold, capital letters and aligned to the left margin,
- **author's name** must be written without titles or degrees, in font size 12, bold, with a single space (size 10) between the name and the text of paper. The job position of the author is stated at the first page as a footnote, while it is marked with the sign * next to the author's name (second author is marked with two signs **, etc.),
- **abstract:** the paper must include an abstract with length between 100 and 150 words, the abstract must be written in font size 10, italic, aligned into block.
- **key words:** from 3 to 5 key words have to be selected by the author and stated under the abstract,
- text of the paper should be divided into **chapters**. Titles of the chapters must be numbered, written in bold type, and aligned to the left margin,
- in the text of the paper it is necessary to follow the format described below:
 - arrangement into block,
 - font style: Arial,
 - font size: 10,
 - indent each new paragraph 5 spaces,
 - spacing: single,
 - do not include page numbers,
- **charts and graphs** have to be numbered and the references must be in the text. The name of a chart (Tab. 1:) or a graph (Fig. 1:) should be written in font size 10, bold, italic, aligned to the left margin and without underlining. Pictures and graphs must be visible and clear even in a black and white version. The source from which the author obtained the material should be written under every chart and graph,
- **formulas** have to be numbered. The number should be written in font size 10 Arial in parentheses, aligned to the right margin and next to the formula,
- **length of papers:** maximum length is 15 pages of A4 format,

- **identification of the research project:** In the case that the paper contains results of a research project, the number and title of the project must be stated at the end of the paper. For example: the paper has been prepared with the support of the project GA SPU no. 999/99/999 “Title of the project”,
- **citation form:** using of the footnote citation form based on the norm ISO 690 is proffered within the journal. It is also required to insert the list of references at the end of the paper,
- always insert notes, quotes and references on the given page using the tools “insert”, “reference” and “footnote”, as this is the only way to secure your inputs without possible errors when processing,
- **author’s address:** the author should provide his/her contact information and co-authors as well at the end of the article below the list of references. It must consist of a first name and surname (including titles and degrees), name of university, name of faculty, name of department (institute) and e-mail address,
- **review:** an anonymous review is arranged by the Editorial Board.
