### 1. License

### 2. Author’s Warranties

### 3. User Rights

### 4. Rights of Authors

Authors retain the following rights:

### 5. Co-Authorship

### 6. Termination

This agreement can be terminated by the author or the Conference Organizer upon two months' notice where the other party has materially breached this agreement and failed to remedy such breach within a month of being given the terminating party's notice requesting such breach to be remedied. No breach or violation of this agreement will cause this agreement or any license granted in it to terminate automatically or affect the definition of the Conference Organizer. After the lapse of forty (40) years of the date of this agreement, this agreement can be terminated without cause by the author or the Conference Organizer upon two years' notice. The author and the Conference Organizer may agree to terminate this agreement at any time. This agreement or any license granted in it cannot be terminated otherwise than in accordance with this section 6.

7. Royalties

This agreement entitles the author to no royalties or other fees. To such extent as legally permissible, the author waives his or her right to collect royalties relative to the article in respect of any use of the article by the Conference Organizer or its sublicensee.

8. Miscellaneous

The Conference Organizer will publish the article (or have it published) in the Journal, if the article's editorial process is successfully completed and the Conference Organizer or its sublicensee has become obligated to have the article published. Where such obligation depends on the payment of a fee, it shall not be deemed to exist until such time as that fee is paid. The Conference Organizer may conform the article to a style of punctuation, spelling, capitalization and usage that it deems appropriate.
