

GENERAL INFORMATION

The Romanian Journal of Cardiology publishes original articles in cardiovascular physiology and pathology as clinical trials, laboratory, experimental, epidemiological studies, etc. All the articles sent for publishing to our journal should not be partially or integrally included in other publications. The authors shall respect the principles of ethics and scientific truth in executing the study, attaining data, and presenting the results.

The accepted papers will be fully citable with the DOI number and indexed in several databases (included Scopus, DOAJ).

Papers must comply to the following rules to enter into the editorial process.

OPEN ACCES AND COPYRIGHT

According to CC-BY Creative Commons attribution license (the current version is CC-BY, version 4.0), the author(s) retains copyright, but the content is free to download, print the full text articles and use them for any other lawful purpose, given appropriate attribution to the original article.

Upon submission, the author(s) grants Sciendo a license to publish, including to display, store, copy, and reuse the content.

AUTHORSHIP

All authors should have contributed substantially to all or any of the following: the concept and design of the study, the acquisition, analysis, or interpretation of data, drafting the manuscript, and revising it critically for essential intellectual content. Each author should approve the final version of the manuscript.

Contributors who do not meet these criteria, should be included in the acknowledgement section.

The corresponding author takes primary responsibility for communication with the journal and editorial office during the submission process, throughout peer review, during publication, and post-publication to respond to any queries.

If it is the case, the first two authors may be listed as the authors who equally contributed to the submitted work and may be considered the „first” authors; this should be clearly indicated on the title page with the following statement below the affiliations: „Both authors equally contributed to the study”.

Once the manuscript is accepted for publication no changes to the authorship will be allowed.

SUBMISSION

Submission to this journal proceeds online. The access is from the homepage of this journal (<https://www.editorialmanager.com/rjc>). The editorial system will guide stepwise the creation and uploading of the various files. The system automatically converts source files to a single Adobe Acrobat PDF version of the article, which is used in the peer-review process.

All correspondence, including notification of the Editors decision and requests for revision, takes place by e-mail, without the need for a hard-copy paper trail. If some authors are unable to provide an electronic version, they have to contact

When submitting the manuscript, it is mandatory to include, as first page, a cover letter to the editor which must state that all the authors approved the submission of the paper, that the research is original and to reveal the significance of the results.

On submission, the authors should specify the category for which their manuscript is intended.

The manuscript text, references, tables, and figure legends should be prepared in a single file. Papers should be submitted as Microsoft Word documents.

THE EDITORIAL PROCESS

A manuscript will be reviewed for possible publication with the understanding that it is being submitted alone at that point in time and has not been published anywhere, simultaneously submitted, or already accepted for publication elsewhere.

The responsibility regarding the content of the article belongs exclusively to the authors. Two referents shall review the texts sent for publishing with no authors' knowledge. The reviewers should not be affiliated with the same institutes as the contributor/s. However, the selection of these reviewers is at the sole discretion of the editor. The journal follows a double-blind review process, wherein the reviewers and authors are unaware of each other's identity. The comments and suggestions (acceptance/ rejection/ amendments in manuscript) received from reviewers are conveyed to the corresponding author. If required, the author is requested to provide a point-by-point response to reviewers' comments and submit a revised version of the manuscript. This process is repeated till reviewers and editors are satisfied with the manuscript.

Should the article be approved for publication, the issuing date shall be communicated. Rejection of the article shall be motivated and sent in writing to the authors.

The unpublished manuscripts shall not be returned to the authors. All the authors shall sign the articles.

All the authors shall sign a declaration regarding the conflict of interests and their contribution to the paper.

CONFLICT OF INTERESTS

All authors must disclose all conflicts of interest during the submission of their manuscript. Any potential conflict of interest should be declared, including (but not limited to) author shareholding in or receipt of lecture honoraria, travel expenses coverage, research grants or consultancy fee from a company whose product features in the submitted manuscript or which manufactures a competing product.

The corresponding author is responsible for the statement of conflict of interest, during submission.

STATEMENT OF HUMAN AND ANIMAL RIGHTS

For research studies using human or animal subjects, the trial's design, conduct and reporting of results must conform to Good Clinical Practice guidelines (such

as the Good Clinical Practice in Food and Drug Administration (FDA)-Regulated Clinical Trials (USA) or the Medical Research Council Guidelines for Good Clinical Practice in Clinical Trials (UK)) and/or to the World Medical Association (WMA) Declaration of Helsinki.

Informed consent must be obtained from the subjects (or their legally authorised representative). The data regarding this issue must be stated in the Methods section of the manuscript. In the case of animal experimentation, authors should also obtain ethical and /or legal approval prior to conducting the research.

The human patients have the right to privacy and any potentially identifiable data or images should not be published without informed consent. It is the responsibility of the authors to ensure that these principles are complied with.

The Editor in Chief reserves the right to reject papers for which the ethical aspects may raise doubts.
